When a foreign worker transfers employers do they have to undertake a health check-up?

Q1

If a foreign worker is waiting for a transfer when he or she is supposed to take a regular health check-up, what should they do?



When foreign workers are waiting to transfer employers, they do not have to undergo a health check-up.

Q2

When do foreign workers have to get health-check-ups?



Regular health check-ups: Employers are required to arrange regular health check-ups for foreign workers six months, 18 months and 30 months after the date on which the employment permit comes into effect.

Supplementary health check-ups: If it is longer than one year since a foreign worker had a health check-up, the new employer is required to arrange for the worker to undergo a supplementary health check-up within seven days of the employment permit coming into effect.

Khám sức khỏe định kỳ: Người sử dụng lao động nên bố trí cho người lao động nhập cư được khám sức khỏe định kỳ sau 6 tháng, 18 tháng và 30 tháng kể từ ngày giấy phép lao động có hiệu lực.

Khám sức khỏe bổ sung: Nếu đã quá 1 năm kể từ lần khám sức khỏe gần nhất, người sử dụng lao động mới phải sắp xếp cho người lao động nhập cư khám sức khỏe bổ sung trong vòng 7 ngày kể từ ngày giấy phép lao động có hiệu lực.

Selama proses pindah majikan, apakah pekerja migran perlu menjalani pemeriksaan kesehatan?

Selama menunggu proses pindah majikan, jika kebetulan saatnya menjalani pemeriksaan kesehatan berkala, apa yang harus diperbuat?



Selama pekerja migran menunggu proses pindah majikan, diperbolehkan tidak menjalani pemeriksaan kesehatan.

Q2

Lalu kapan pekerja migran harus menjalani pemeriksaan kesehatan?



Pemeriksaan Kesehatan Berkala: Izin perekrutan dengan masa berlaku genap 6 bulan, 18 bulan dan 30 bulan, maka majikan harus menjadwalkan pekerja migran menjalani pemeriksaan kesehatan berkala.

Pemeriksaan Kesehatan Tambahan: Apabila jeda waktu dengan pemeriksaan kesehatan sebelumnya lebih dari 1 tahun, setelah izin perekrutan majikan baru berlaku, maka majikan baru harus menjadwalkan pekerja migran menjalani pemeriksaan kesehatan tambahan dalam kurun waktu 7 hari.
