- ห้ามแรงงานต่างชาติหยุดพักหรือออกไปข้างนอก
- ช่วงเวลาพักผ่อน จำกัดเสรีภาพในการใช้อุปกรณ์สื่อสารส่วนตัว หรือยึดมือถือของแรงงานต่างชาติ

Restricting the freedom of foreign workers

My employer told me I have to remain in my residence, cannot go out during time off and must get permission to call family or friends. Is that legal?



It is illegal!

Employers or other parties cannot use illegal methods to strip foreign workers of their freedom of movement, including the following situations:

- Restrict a foreign worker's leave time or right to go out
- Restrict a foreign worker's ability to communicate with others or confiscate their cellphone when they are not working

Khi tôi nghỉ phép, chủ thuê yêu cầu tôi ở nhà nghỉ ngơi, không được đi ra ngoài, tôi cũng cần phải được phép mới có thể nói chuyện với người thân và bạn bè. Điều này có hợp pháp không?



Không hợp pháp.

Người sử dụng lao động hoặc bất kỳ ai khác, đều không được dùng phương pháp bất hợp pháp để tước quyền tự do đi lại của người lao động nhập cư. Nếu bạn gặp phải những tình huống sau:

- Hạn chế người lao động nghỉ phép hoặc đi ra ngoài.
- Hạn chế quyền tự do liên lạc cá nhân hoặc tịch thu điện thoại di động của người lao động trong giờ nghỉ của họ.

Tidak Legal!

Majikan atau siapa pun tidak diperkenankan membatasi kebebasan bergerak pekerja migran secara ilegal. Jika Anda mengalami kondisi berikut:

- Membatasi pekerja migran untuk berlibur atau keluar.
- Membatasi kebebasan komunikasi pribadi pekerja migran atau penyitaan ponsel selama waktu istirahat pribadi.
